Separate sealed Bids for the construction of the **Bent Creek Sewer Extension – Phase 3** will be received by **Greer Commission of Public Works** (herein called the Owner) at the Boardroom of the **Public Works Office, 301 McCall Street, Greer, South Carolina 29650** until **2:00 p.m.** local time on **October 22, 2019** at which time the Bids received will be publicly opened and read aloud.

The Project consists of the construction of approximately 3,115 feet of 15-inch and 16-inch gravity sewer, 3,655 feet of 12-inch gravity sewer, 26 manholes, erosion control, restoration and grassing, testing and all other related appurtenances.

This project is being funded in whole or in part by the Community Development Block Grant Program (CDBG). All federal CDBG requirements will apply to the contract. All contractors and subcontractors are required to be registered in the federal System for Award Management (SAM). Bidders on this work will be required to comply with the President's Executive Order No. 11246 & Order No. 11375 which prohibits discrimination in employment regarding race, creed, color, sex, or national origin. Bidders must comply with Title VI of the Civil Rights Act of 1964, the Davis-Bacon Act, the Anti-Kickback Act, the Contract Work Hours and Safety Standards Act, and 40 CFR 33.240.

Bidders must also make positive efforts to use small and minority-owned business and to offer employment, training and contracting opportunities in accordance with Section 3 of the Housing and Urban Development Act of 1968. Attention of bidders is particularly called to the requirements as to conditions of employment to be observed and minimum wage rates to be paid under the contract.

All bidders are advised that the application with cost estimate is available for review. The owner reserves the right to waive any irregularities, or to reject any or all bids. No bidder may withdraw his bid within 90 days after the actual date of the opening thereof.

Neither the State of South Carolina nor the United States nor any of their Departments, Agencies, or employees is or will be a party to this Advertisement for Bids or any resulting contract. The contract will be subject to all applicable federal, state and local rules, regulations, laws, and orders. The attention of the bidder is particularly called to the ARC Contract Special Provisions included in Appendix A of the Project Manual.

A non-mandatory pre-bid conference will be held at 2 p.m. local time on October 3, 2019 at the Boardroom of the **Public Works Office, 301 McCall Street, Greer, South Carolina 29650**. Representatives of the Owner and Engineer will be present to discuss the Project. Attendance at the pre-bid conference is highly encouraged but is not mandatory. Engineer will transmit (through QuestCDN) to all prospective Bidders of record such Addenda as Engineer considers necessary in response to questions arising at the conference. Oral statements may not be relied upon and will not be binding or legally effective.

A Bid Bond in the amount of five percent (5%) will be required. A performance Bond and a Payment Bond, each in the amount of one hundred percent (100%) of the contract, must be furnished by the successful bidder upon award of the contract.

Prospective Bidders must purchase contract documents through Quest Construction Data Network (QUESTCDN). This can be done through the Design South Website: www.designsouthprofessionals.com by selecting this project from the "Project Bid Info" link under the RESOURCES tab or on the QUESTCDN website (www.questcdn.com). QUESTCDN is a web-based platform for construction project advertisements, bid documents distribution and plan holder lists. Prospective bidders will need the seven-digit QUESTCDN project number **6499813** to locate the job on the QUESTCDN website search page. There is a \$50.00 nonrefundable cost for downloading the contract documents in a pdf format. Bids will not be accepted from any prospective bidder who has not purchased contract documents through QUESTCDN.

Any bid may be withdrawn prior to the above scheduled time for the opening of bids or authorized postponement thereof. Any bid received after the time and date specified will not be considered.

Bid security shall be furnished in accordance with the Instructions to Bidders.
