Welcome to Lakes Robinson and Cunningham. Please do not hesitate to call on us at (864) 895-3645 at any time. We want to assist you in any way we can, or answer questions that you may have concerning the "Shoreline Area". The "Shoreline Area" is the body of land that is between your property and the lake owned by Greer Commission of Public Works, Greer, SC. Please observe the 50' set back line above the 900 M.S.L at Lake Robinson and the 850 M. S. L. at Lake Cunningham.

Please observe all Greer Commission of Public Works rules and regulations when permitted to participate on the lakes and premises. Plan your activities while on the property during our daylight hours of operations. If you observe any activity on the "Shoreline Area" or on the lake itself after hours, please call our 24-hour emergency phone number, (864) 848-5500. You will not have to reveal your identity to our operations center.

Any intent that you have to beautify the "Shoreline Area" must be presented to the Lake Warden in written form. Any gardening, placement of rip-rap, irrigation, dock construction, cutting bushes or trees, digging, or planting activity must be approved in writing from Greer CPW. None of the listed or any other activity is authorized without "Written Approval" form Greer CPW.

All permits for beautification of the "Shoreline Area" expire after one year from date of approval, even though all phases may not have been completed. You may submit another "Letter of Intent" to this office requesting a new permit. Any intentions or activity on the "Shoreline Area" must be reported to this office, (864) 895-3645, prior to and after each phase of work as accomplished.
