NEW BUSINESS

Mr. Richard indicated that the agreement with PMPA will expire 2035; however, it is always advisable to get started on the Power Sales Agreement years in advance. At this time, PMPA would like to know our interest in negotiating a new Power Sales Agreement; therefore, Mr. Richard asked the board to approve the Nonbinding PMPA Letter of Intent. He further stated that signing this nonbinding letter of intent does not obligate us and we will work with PMPA to finalize a formal agreement prior to October 1, 2018. Also, Mr. Richard said there are some good refunding opportunities in 2022 and explained that prices are going to stabilize and we may even see that the prices go down. The Agreement will be executed through City Council.

Jeff Howell made a motion to approve the Nonbinding PMPA Letter of Intent with open concept of extending at termination date. Perry Williams seconded the motion. A roll call vote followed. Mr. Gibson voted yes. Mr. Howell voted yes. Mr. Williams voted yes.
