



Incentive Package for Gas Customers Converting from Alternate Fuel Terms and Conditions

The purpose of this policy is to promote the use of natural gas on Greer CPW's system through the use of incentives for when converting alternate fuel (propane, fuel oil, electric) appliances to natural gas. This policy applies only to residential and commercial customers that convert their alternate fuel appliances to natural gas after, September 26, 2011.

Eligibility Requirements: Available to any customer where natural gas service is provided. Customer must convert an alternate fuel (propane, fuel oil, electric) appliance to natural gas. These appliances are a gas furnace, gas pack, vented gas space heater, or gas hot water heater.

- Customers that convert their primary heating systems to natural gas such as gas furnaces, gas packs or vented gas space heaters will receive a refund incentive of \$400.00. The refund will be issued after the installation of the appliances is complete and an inspection by the appropriate authority is performed.
- Customers that convert to a gas hot water heater will receive a refund incentive of \$400.00. The refund will be issued after the installation of the hot water heater is complete and an inspection by the appropriate authority is performed.

This offer is not available for new construction of homes, condominiums, apartments, or townhomes. This incentive is only available for the conversion of appliances using alternate fuels (propane, fuel oil, and electric).

Appliances must be converted by a HVAC or plumbing contractor licensed in South Carolina. A permit is also required by the city or county where the customer's home is located.

An application for refund must be submitted and approved before refund is issued. Applications should include a copy of the proof of installation (receipt/invoice/contract) and/or copy of the proof of purchase (sales receipt). Application should also include a copy of the permit. Application of rebate should be received within 90 days of the date of the conversion. Rebates only apply to appliances converted or installed after the date of September 26, 2011 when Greer CPW approved the program. Gas meter must be set before rebate can be issued. This promotion may be discontinued or modified at any time by Greer CPW without notice.
