RENTAL LIGHT SERVICE SCHEDULE**

**SCHEDULE L
OUTDOOR LIGHT RATE**

AVAILABILITY

Available to the individual customer for lighting of private and public outdoor areas at locations on the CPW's distribution system. This Schedule is intended for all standard, non-decorative lighting. Service under this Schedule may be withheld or discontinued at the option of the CPW.

Owner of property must submit an online request to install new service as well as pay a one-time installation fee.

- (1) Non-LED lighting includes any other luminaire that is not a Light Emitting Diode (LED). This includes, but not limited to, high pressure sodium vapor (HPS), metal halide, and mercury vapor luminaires.
- (2) Greer CPW no longer offers non-LED lights. These rates are provided as information only for those customers who have existing non-LED light fixtures. As these lights become non-operational in the future, they will be replaced with LED lights and the applicable LED rate will be charged. Replacement of operational non-LED lighting is subject to the Transition Fee listed below

RESIDENTIAL SECURITY LIGHT INSTALLATION FEES

Installation on an existing pole:

A fee of \$200 applies when the light can be mounted to an existing pole.

Installation of a New Pole:

A fee of \$320 applies when a new pole must be installed to accommodate the light.

If the light installation requires service to be extended more than 100 feet from the nearest power source or more than one pole, additional charges will apply to cover the cost of materials and labor.

Transition Fee

CPW will replace operational non-LED lighting with an LED light upon payment of a transition fee in the amount of \$50.00, in advance, per lighting fixture.

SALES TAX

Any applicable sales tax will be added to the monthly bill as determined above.

INTERRUPTION OF SERVICE

The CPW will make reasonable provisions to ensure satisfactory and continuous service, but does not guarantee a continuous supply of electrical power and energy and shall not be liable for damage occasioned by interruptions of service or failure to commence delivery caused by acts of God, or the public enemy, or for any cause reasonably beyond its control, including, but not limited to the failure or breakdown of facilities, floods, fire, strikes, or action or orders of any agency having jurisdiction in the premises, or for interruptions which are necessary for inspection, repair, or changes in equipment or facilities of the CPW or its bulk power suppliers. The customer shall notify the CPW immediately of any defects, trouble or accident that may in any way affect the delivery of electric service by the CPW.

PAYMENT

Bills are due and payable on the date of the bill at the offices of the Greer Commission of Public Works. Bills are past due and delinquent on the nineteenth (19th) day after the date of the bill, at which time customer will be assessed a late charge equal to five percent (5%) of the unpaid past due amount. Disconnection may occur on the 29th day after the date of bill or thereafter unless prior arrangements have been made with the CPW. Any customer who has his or her services terminated for non-payment shall also be subject to a \$75.00 non-payment fee for services to be restored during normal business hours or \$100 if services are restored after normal business hours.
