

**GREER CPW
WATER SERVICE SCHEDULE**

**RATE CODE W700
MASTER METERS
INSIDE CITY LIMITS**

AVAILABILITY

This rate is available to all commercial water customers that provide residential dwellings (apartments, duplexes, etc.) or business complexes located within the CPW's service area and inside the corporate limits of the City of Greer. These customers must use a master meter to monitor usage to an apartment/residential complex that houses multiple units or a business complex with multiple units.

Water Supplied under this schedule is for the exclusive use of the customer and shall not be resold, without authorization from the CPW.

Master meters with multiple minimums are not subject to facilities charges based on meter size. They will be billed by the following:

BASE CHARGES

Facilities Charge: \$ 10.09 per month X Number of Units that Master Meter Serves

Example: A meter serves 24 apartments. The facilities charge shall be \$10.09 X 24 which is \$242.16. Volume charges would then be added.

It is the property owner's responsibility to notify Greer CPW should the number of units change.

Volume Charge:

First 4,000 gallons	\$1.410 per 1,000 gallons
All over 4,000 gallons	\$1.720 per 1,000 gallons

MINIMUM MONTHLY BILL

The minimum monthly charge shall be the "Facilities Charge".

INTERRUPTION OF SERVICE

The CPW will make reasonable provisions to ensure satisfactory and continuous service, but does not guarantee a continuous supply of water and shall not be liable for damage occasioned by interruptions of service or failure to commence delivery caused by acts of God, or the public enemy, or for any cause reasonably beyond its control, including, but not limited to the failure or breakdown of facilities, floods, fire, strikes, or action or orders of any agency having jurisdiction in the premises, or for interruptions which are necessary for inspection, repair, or changes in equipment or facilities of the CPW. The customer shall notify the CPW immediately of any defects, trouble or accident that may in any way affect the delivery of water service by the CPW.

SINGLE POINT DELIVERY

The above rates are based upon the supply of service to the customer's premises through a single delivery and metering point. Separate supply for the same customer at other points of consumption shall be separately metered and billed.

PAYMENT

Bills are due and payable on the date of the bill at the offices of the Greer Commission of Public Works. Bills are past due and delinquent on the nineteenth (19th) day after the date of the bill, at which time customer will be assessed a late charge equal to five percent (5%) of the unpaid past due amount. Disconnection may occur on the 29th day after the date of bill or thereafter, unless prior arrangements have been made with the CPW. Customers who fail to pay the past-due balance by the cutoff date will be subject to a \$75 non-payment fee, which will be added immediately to the account and appear on the next billing cycle. For reconnection requests made after 3:00 PM, Monday through Friday, that require a same-day technician visit, an additional \$100 fee will apply and will be reflected on the next billing cycle.

OBLIGATIONS

The obligations of the CPW in regard to supplying water service are dependent upon its securing and retaining all necessary rights-of-way, privileges and permits for the delivery of such service. The CPW shall not be liable to any customer or applicant for water service in the event it is delayed in, or is prevented from, furnishing the water service by its failure to secure and retain such rights-of-way, privileges and permits.
