

GREER CPW GAS SERVICE SCHEDULE

RATE CODE G100 RESIDENTIAL RATE

AVAILABILITY

This rate schedule is available to all domestic gas customers within the territory served by the CPW.

This rate schedule is applicable to all gas service exclusively for domestic purposes to individual (single family) private residences, apartments, condominiums, mobile homes or farms. No gas purchased under this rate schedule shall be resold for any purpose.

BASE CHARGES

Facilities Charge: \$10.00 per month

Usage Charges (per CCF):

Distribution Charge: \$0.35500 per CCF

Interstate Pipeline Charge: \$0.23125 per CCF

Purchased Gas Charge: \$0.64503 per CCF

MINIMUM MONTHLY BILL

The minimum monthly charge shall be the "Facilities Charge".

FRANCHISE FEES

Greer CPW will also collect a franchise fee on behalf of the City of Lyman, Town of Duncan, City of Wellford, Town of Reidville and City of Landrum to all customers associated with this rate in those municipalities. This rate is determined and set by those cities and townships.

PURCHASED GAS ADJUSTMENT

Any consumption under this rate is subject to the PGA rate.

SALES TAX

Any applicable sales tax will be added to the monthly bill as determined above.

INTERRUPTION OF SERVICE

The CPW will make reasonable provisions to ensure satisfactory and continuous service, but does not guarantee a continuous supply of natural gas and shall not be liable for damage occasioned by interruptions of service or failure to commence delivery caused by acts of God, or the public enemy, or for any cause reasonably beyond its control, including, but not limited to the failure or breakdown of facilities, floods, fire, strikes, or action or orders of any agency having jurisdiction in the premises, or for interruptions which are necessary for inspection, repair, or changes in equipment or facilities of the CPW. The customer shall notify the CPW immediately of any defects, trouble or accident that may in any way affect the delivery of natural gas by the CPW.

SINGLE POINT COLLECTION

The above rates are based upon the supply of service to the customer's premises through a single collection point. Separate supply for the same customer at other points of collection shall be separately billed.

PAYMENT

Bills are due and payable on the due date of the bill at the offices of the Greer Commission of Public Works. Bills are past due and delinquent on the first business day after the due date shown on bill, at which time customer will be assessed a late charge equal to five percent (5%) of the most current unpaid past due amount. Disconnection may occur on the 11th day following the due date of bill or thereafter, unless prior arrangements have been made with the CPW. Customers who fail to pay the past-due balance by the cutoff date will be subject to a \$75 non-payment fee, which will be added immediately to the account and appear on the next billing cycle. For reconnection requests made after 3:00 PM, Monday through Friday, that require a same-day technician visit, an additional \$100 fee will apply and will be reflected on the next billing cycle.

OBLIGATIONS

The obligations of the CPW in regard to supplying natural gas collection services are dependent upon its securing and retaining all necessary rights-of-way, privileges and permits for the delivery of such service. The CPW shall not be liable to any customer or applicant for natural gas collection service in the event it is delayed in, or is prevented from, furnishing the natural gas collection service by its failure to secure and retain such rights-of-way, privileges and permits.
